The National Council has directed me to inform and invite you take part at the Canadian Hellenic Congress (CHC) November 2022 National Convention. The National Convention will be held on Sunday November 27, 2022.

Both the Conference and Annual General Meeting will be conducted via electronic means. The Annual General Meeting (AGM) will be held in the morning of Sunday, November 27, 2022, and the Conference in the afternoon.

The AGM will start at 10:30 a.m. and end at 1:30 p.m. It will be held via electronic means. The AGM Notice and Agenda is attached to these communications as **Appendix A.**

**Only regular paid-up members are entitled to have delegates to the Convention**. If your membership has expired you must pay up your current membership fees

and any arrears that you have outstanding, no later than October 1, 2022. Former members, including provincial organizations, who have lost membership

status due to their non-participation and non-payment of their membership fees for a period of at least (3) three years are not recognized nor have any rights to be engaged in the business of the AGM must apply to be reinstated and acquire membership rights.

Any former member, including a provincial organization, who wishes to be reinstated to full membership status must apply to the National Council on or before **September 1, 2022.** 

The application, which it could be in a form of a letter, addressed to the Secretary of the Congress, <u>chc@chcongress.ca</u> must be accompanied by a **certified Board Resolution** <u>signed by all the directors of the Former Member, in which it states</u> <u>that it freely desires to rejoin the Congress, the Former Member recognizes and</u> <u>acknowledges that the Congress as the National Canadian Hellenic institution and</u> <u>accepts, recognizes and adheres to the Constitution of 2016, as amended, as the</u> <u>principal governing document, and accepts and recognizes the current officers</u> <u>and directors as constituted following the 2019 National Council elections.</u>

# Pays the current and all past dues to the Congress

Complies with the membership requirements as set out in Article 9 of the Constitution. (<u>https://chcnews.org/docs/chcbylaws2016.pdf</u>)

In accordance with the **Reinstatement Membership Policy**, the National Council is authorized to review and decide on the former member's application for reinstatement.

Non-members can participate at the Convention but will not have the right to vote but may speak at the AGM with the consent of the registered delegates.
